NOTES

Democrat (D), *Republican (R)*

- a) American Samoa Lt. Governor Togiola T.A. Tulafono became governor on April 7, 2003, following the death of Governor Tauese Sunia on March 26, 2003.
- b) Arkansas Lt. Governor Mike Huckabee became governor in July 1996 after Governor Jim Guy Tucker resigned. Governor Huckabee was elected to full four-year terms in November 1998 and November 2002.
- c) Arnold Schwarzenegger was elected governor of California in October 2003 following the recall of Governor Gray Davis. Governor Schwarzenegger was inaugurated on November 17, 2003.
- d) Connecticut Lt. Governor M. Jodi Rell became Governor on July 1, 2004 following the resignation of Governor John G. Rowland.
- e) Absolute two-term limitation, but terms need not be consecutive.
- f) Idaho Lt. Governor James. E. Risch became governor on May 26th, 2006 following the appointment of Gov. Dirk Kempthorne to the office of U.S. Secretary of the Interior.
- g) Absolute limit of eight years of service out of every 16 years.
- h) Nebraska Lt. Governor Dave Heineman became governor on January 21, 2005 following the appointment of Gov. Mike Johanns to the office of U.S. Secretary of Agriculture.
- i) After two consecutive terms as governor, the candidate must wait four years before becoming eligible to run again.
- j) Two-year term.
- k) Texas Lt. Governor Rick Perry became governor in December 2000 when Governor George W. Bush was elected President. Governor Perry was elected to a full four-year term in November 2002.
- l) Two-year term.
- m) Governor cannot serve immediate successive terms.
