Wisconsin Gov. Scott Walker issued an <u>Executive Order</u> allowing the National Guard to assist the WI Elections Commission upon request.

Washington Gov. Jay Inslee <u>appeared alongside</u> Washington's Secretary of State as the two explained how their state is preparing to defend election infrastructure.
