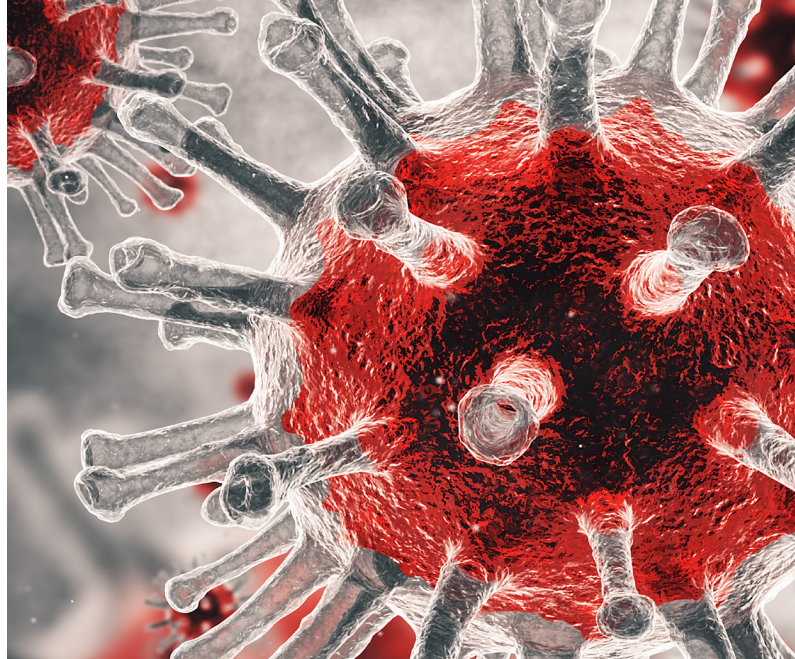
Recent outbreaks of Coronavirus (COVID-19) have heightened the need for remediation and decontamination of common interior surfaces and the safe disposal of infected materials.
